(Grade I)

FOR TWO-YEAR-OLDS By subscription of \$100 each if made on or before Thursday, September 19, 2019, or by supplementary nomination of \$6,000 at time of entry. All horses shall pay \$4,500 to enter with \$300,000 guaranteed. The winner to receive \$180,000, PLUS 10 KY Derby points, \$60,000 to second, \$36,000 to third, \$18,000 to fourth and \$6,000 to fifth. Weight 122 lbs. The American Pharoah Stakes has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the American Pharoah Stakes will be entitled to automatic entry into the 2019 running of the Breeders' Cup Juvenile division. The nominated winner will be entitled to have pre-entry and entry fees waived for the Championship race, and will be entitled to receive a travel stipend if traveling from a location outside the state of California. To be eligible for the 2019 Breeders' Cup Championships to be held at Santa Anita on November 1 and 2, 2019, all horses must be pre-entered by NOON (PDT) at the designated pre-entry locations on Monday, October 21, 2019. Winner must be Breeders' Cup nominated by pre-entry deadline to receive Challenge rewards. A trophy will be presented to the owner of the winner.
