

## Autumn Miss Stakes \$100,000 Guaranteed

## (Grade III)

**FOR FILLIES THREE YEARS OLD** By subscription of \$100 each if made on or before Thursday, October 17, 2019 or by supplementary nomination of \$2,000 by time of entry. All horses to pay \$1,500 to enter with \$100,000 guaranteed. The winner to receive \$60,000, \$20,000 to second, \$12,000 to third, \$6,000 to fourth and \$2,000 to fifth. 124 lbs. Non-winners of a sweepstakes at one mile or over, allowed 2 lbs. Non-winners of a two races other than claiming at one mile or over allowed 4 lbs. High weights preferred. Preference to start to be determined by Graded Stake Winners. Second preference to Graded Stakes placed horses, followed by highest earners. Starters to be named through the entry box by the usual time of entries. A trophy will be presented to the owner of the winner.
