\$300,000 Guaranteed
(Grade I)

FOR FILLIES AND MARES THREE YEARS OLD AND UPWARD By subscription of \$100 each made on or before Thursday, September 19, 2019 or by supplementary nomination of \$6,000 at time of entry. All horses shall pay \$4,500 to enter with \$300,000 guaranteed. The winner to receive \$180,000, \$60,000 to second, \$36,000 to third, \$18,000 to fourth and \$6,000 to fifth. Three-Year-Olds: 122 lbs. Older: 125 lbs. Non-winners of a Grade I at One Mile or Over on the turf Since October 1, 2018, allowed 2 lbs. Of a Grade II at One Mile or Over on the Turf in 2019 or a Grade I at One Mile or over on the Turf in 2018, allowed 4 lbs. The Rodeo Drive Stakes has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the Rodeo Drive Stakes will be entitled to automatic entry into the 2019 running of the Breeders' Cup Filly & Mare Turf. The nominated winner will be entitled to have pre-entry and entry fees waived for the Breeders' Cup Filly & Mare Turf or will receive a credit equal to the Breeders' Cup Filly & Mare Turf pre-entry and entry fee amount towards any other Breeders' Cup Championship race, and will be entitled to receive a travel stipend if traveling from a location outside the state of California. The nominated winner of the Rodeo Drive Stakes will be entitled to automatic entry into the 2019 running of the Breeders' Cup Filly & Mare Turf division. To be eligible for the 2019 Breeders' Cup Championships to be held at Santa Anita on November 1 and November 2, 2019, all horses must be pre-entered by NOON (EST) at the designated pre-entry locations) on Monday, October 21, 2019. Winner must be Breeders' Cup nominated by pre-entry deadline to receive Challenge rewards. A trophy will be presented to the owner of the winner.
