



## Speakeasy Stakes

### Breeders' Cup "Win and You're In" Challenge Race

**\$100,000 Guaranteed**

**FOR TWO-YEAR-OLDS** By subscription of \$100 due on or before Thursday, September 26, 2019 or by supplementary nomination of \$2,000 by time of entry. All horses to pay \$1,500 to enter, with \$100,000 guaranteed. The winner to receive \$60,000, \$20,000 to second, \$12,000 to third, \$6,000 to fourth and \$2,000 to fifth. 124 lbs. Non-winners of a sweepstakes allowed 2 lbs. Non-winners of a race other than Maiden, Claiming or Starter 4 lbs. Highweights Preferred, followed by Graded Stake Winners; Graded Stakes placed horses; Stakes winners; followed by highest earners. The Speakeasy Stakes has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the Speakeasy Stake will be entitled to automatic entry into the 2019 running of the Breeders' Cup Juvenile Turf Sprint. The nominated winner will be entitled to have pre-entry and entry fees waived for the Breeders' Cup Juvenile Turf Sprint or will receive a credit equal to the Breeders' Cup Juvenile Turf Sprint pre-entry and entry fee amount towards any other Breeders' Cup Championship race and will be entitled to receive a travel stipend if traveling from a location outside the state of California. To be eligible for the 2019 Breeders' Cup Championship to be held at Santa Anita on November 1 and November 2, 2019, all horses must be pre-entered by NOON (EST) at the designated pre-entry locations on Monday, October 21, 2019. Winner must be Breeders' Cup nominated by pre-entry deadline to receive Challenge rewards. Starters to be named through the entry box by the usual time of closing. The Owner of the winner to receive a trophy.
