



**Shoemaker Mile**  
**Breeders' Cup "Win and You're In" Challenge Race**  
**\$300,000 Guaranteed**  
**(Grade I)**

**FOR THREE-YEAR-OLDS AND UPWARD** By subscription of \$100 each to accompany the nomination or by Supplementary nomination of \$6,000 due at time of entry. \$2,250 to enter and an additional \$2,250 to start, with \$300,000 guaranteed of which \$180,000 to the winner, \$60,000 to second, \$36,000 to third, \$18,000 to fourth and \$6,000 to fifth. Three-year-olds 120 lbs. Older 126 lbs. Non winners of a Grade I stake at One Mile or Over since November 25, 2019 allowed 2 lbs. Non winners of a Grade I or Grade II stake at One Mile or Over since May 25, 2019 allowed 4 lbs. \*The Shoemaker Mile has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the Shoemaker Mile will be entitled to automatic entry into the 2020 running of the Breeders' Cup Mile division. The nominated winner will be entitled to have pre-entry and entry fees waived (\$60,000 value) for the Championship race, and will be entitled to receive a travel stipend if traveling from a base located outside the state of Kentucky. To be eligible for the 2020 Breeders' Cup World Championships held at Keeneland Race Course on November 6 and 7, 2020 all horses must be pre-entered by noon (local standard time at the designated place of pre-entry) on Monday, October 26, 2020. Winner must be Breeders' Cup nominated by pre-entry deadline to receive Challenge rewards. Starters to be named through the entry box by the closing time of entries. A trophy will be presented to the winning owner.
