FOR FOUR- YEAR-OLDS AND UPWARD By subscription of \$100 each to accompany the nomination or by supplementary nomination of \$4,000 at time of entry. \$1,500 to enter (Horses that start in the race will have entry fee waived) and an additional \$1,500 to start with \$200,000 guaranteed of which \$120,000 to the winner, \$40,000 to second, \$24,000 to third, \$12,000 to fourth and \$4,000 to fifth. 124 lbs. Non-winners of a Grade I or Grade II stake at One Mile or Over since July 2, 2020 allowed 2 lbs.; Non-winners of a Graded Stakes at One Mile or Over since January 2, 2020 allowed 4 lbs. Starters to be named through the entry box by the closing time of entries. A trophy will be presented to the winning owner.
