FOR FILLIES, THREE-YEAR-OLDS By subscription of \$100 each to accompany the nomination or by supplementary nomination of \$4,000 due at time of entry. \$1,500 to enter (Horses that start in the race will have entry fee waived) and an additional \$1,500 to start with \$200,000 guaranteed of which \$120,000 PLUS TEN KENTUCKY OAKS POINTS to the winner. \$40,000 (Four Ky. Oaks Points) to second, \$24,000 (Two Ky.Oaks Points) to third, \$12,000 (One Ky. Oaks Points) to fourth, and \$4,000 to fifth. 124 lbs. Non-winners of a Graded Stakes allowed 2 lbs.; Non-winners of a race other than Maiden, Claiming or Starter allowed 4 lbs. Starters to be named through the entry box by the closing time of entries. A trophy will be presented to the winning owner.
