



Shoemaker Mile
Breeders' Cup "Win and You're In" Challenge Race
\$300,000 Guaranteed
(Grade I)

FOR THREE-YEAR-OLDS AND UPWARD By subscription of \$100 each to accompany the nomination or by Supplementary nomination of \$6,000 due at time of entry. \$2,250 to enter and an additional \$2,250 to start, with \$300,000 guaranteed of which \$180,000 to the winner, \$60,000 to second, \$36,000 to third, \$18,000 to fourth and \$6,000 to fifth. Three-year-olds 120 lbs. Older 126 lbs. Non winners of a Grade I stake at One Mile or Over since November 30, 2020 allowed 2 lbs. Non winners of a Grade I or Grade II stake at One Mile or Over since May 31, 2020 allowed 4 lbs. *The Shoemaker Mile has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the Shoemaker Mile will be entitled to automatic entry into the 2021 running of the Breeders' Cup Mile Turf division, nominated winner will be entitled to have pre-entry and entry fees waived for the Breeders' Cup Mile Turf or will receive a credit equal to the Shoemaker Mile pre-entry and entry fee amount towards any other Breeders' Cup Championship race, and all horses will be entitled to receive a travel stipend if traveling from a base located outside the state of California. To be eligible for the 2021 Breeders' Cup World Championships held at Del Mar on November 5 and 6, 2021, all horses must be pre-entered by noon (local standard time at the designated place of pre-entry on Monday, October 25,2021. Winner must be nominated by pre-entry deadline to receive Challenge rewards. All Breeders' Cup Challenge Races and Breeders' Cup World Championship races are to be run Lasix free. In the event a designated Breeders Cup Challenge turf race is taken off the turf, due to unsafe racing conditions, the horse that wins the "off the turf" race will not receive an automatic qualifying position and will not receive the starting fees (the total of pre-entry and entry fees) to enter the Championships in the applicable Turf Division race; provided, however, that Breeders' Cup Limited may, at its option, reinstate the "Win and You're in" status of the "off the turf" race. The decision to take a Breeders' Cup Challenge Division turf race off the turf course is under the sole discretion of the racetrack/racing association, not Breeders' Cup Limited. All runners nominated to Challenge races are subject to out-of-competition testing by the California Horse Racing Board and/or BCL. All Challenge winners are subject to out-of-competition testing conducted by the California Horse Racing Board and/or BCL. Breeders' Cup Limited reserves the right in its sole discretion to postpone, discontinue, amend or change the conditions of all or any part of the Breeders' Cup Challenge "Win & You're In" race program.
