Breeders' Cup "Win and You're In" Challenge Race

\$100,000 Guaranteed

FOR TWO-YEAR-OLDS By subscription of \$100 each due on or before Friday, September 17, 2021 or by supplementary nomination of \$2,000 by time of entry. All horses to pay \$750 to enter and an additional \$750 to start with \$100,000 guaranteed of which \$60,000 to the winner, \$20,000 to second, \$12,000 to third, \$6,000 to fourth and \$2,000 to fifth. 122 lbs. Non-winners of a Sweepstakes allowed 2 lbs. Non-winners of a Race other than Maiden, Claiming or Starter 4 lbs. Highweights Preferred, followed by Graded Stake Winners; Graded Stakes placed horses; Stakes winners; followed by highest earnings in non-claiming/starter races in the past 12 months prior to race date. The Speakeasy Stakes has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the Speakeasy Stakes will be entitled to automatic entry into the 2021 running of the Breeders' Cup Juvenile Turf Sprint, nominated winner will be entitled to have pre-entry and entry fees waived for the Breeders' Cup Juvenile Turf Sprint or will receive a credit equal to the Breeders' Cup Juvenile Turf Sprint pre-entry and entry fee amount towards any other Breeders' Cup Championship race, and all horses will be entitled to receive a travel stipend if traveling from a base located outside the state of California. To be eligible for the 2021 Breeders' Cup World Championship to be held at Del Mar on November 5 and November 6, 2021, all horses must be pre-entered by noon (local standard time at the designated place of pre-entry) on Monday, October 25, 2021. Winner must be nominated by pre-entry deadline to receive Challenge rewards. All Breeders' Cup Challenge Races and Breeders' Cup World Championship races are to be run Lasix free. In the event a designated Breeders' Cup Challenge turf race is taken off the turf, due to unsafe racing conditions, the horse that wins the "off the turf" race will not receive an automatic qualifying position and will not receive the starting fees (the total of pre-entry and entry fees) to enter the Championships in the applicable Turf Division race; provided, however, that Breeders' Cup Limited may, at its option, reinstate the "Win & You're In" status of the "off the turf" race. The decision to take a Breeders' Cup Challenge Division turf race off the turf course is under the sole discretion of the racetrack/racing association, not Breeders' Cup Limited. All runners nominated to Challenge races are subject to out-of-competition testing by the California Horse Racing Board and/or BCL. All Challenge winners are subject to out-of-competition testing conducted by the California Horse Racing Board and/or BCL. Breeders' Cup Limited reserves the right in its sole discretion to postpone, discontinue, amend or change the conditions of all or any part of the Breeders' Cup Challenge "Win & You're In" race program.
